 security of financial history.
- · Notification of the award will be prior to annual SDSA Luncheon and presented at the Luncheon.
- Awards will be paid directly to the educational institution on behalf of and in the student's name after the student accepts the award; the award is earmarked for tuition, books and lab fees.
