## PART 3: BUSINESS MEMBER TIERS

- Individual - \$325:** For an individual artist or one person operating a business from a home office with no other employees, family members, or spouse.
- Small Business - \$500:** 10 on-site employees or less, including full-time, part-time, and back office/maintenance employees. Seasonal staff and independent contractors do not apply.
- Educational, Non-Profit, Not for Profit or Charity - \$500:** Accredited schools and associations or businesses that are legally certified to operate for the public good and mutual benefit. State or federal non-profit or not for profit current status and articles of incorporation required for verification.
- Line/Manufacturers Rep, Gallery Rep or Product Placement House - \$500:** Wholesale sellers who represent merchandise lines from various manufacturers or distributors; or galleries or representatives who promote multiple artists; or product placement/brand integration houses. SDSA member advertising is open only to the Business Member showing the range of companies they represent, not to each line or artist individually. For Product Placement, provide a client list with the application.
- Intermediate Business - \$850:** 11-20 on-site employees, including full-time, part-time, and back office/maintenance employees. Seasonal staff and independent contractors do not apply.
- Large Business - \$1,000:** 21-100 on-site employees, including full-time, part-time, and back office/maintenance employees. Seasonal staff and independent contractors do not apply.
- Studio or Production Company - \$2,000**
- Corporate - \$2,500**
