•	Educational or Non/Not for Profit or Charity: Accredited schools and associations or businesses that are legally certified to operate for the public good and mutual benefit. State or Federal Non/Not for Profit current status and articles of incorporation required for verification\$500
•	Line/Manufacturers Rep, Gallery Rep, Product Placement House: Wholesale sellers who represent merchandise lines from various manufacturers or distributors; or galleries or reps who promote multiple artists; or product placement/brand integration houses. SDSA Member advertising is open only to the Business Member showing the range of companies they represent, not to each line or artist individually.
